Lakeland Eye Clinic, No. 8:14-cv-02421, U.S.D.C., M.D. Fla. – transgender employee terminated for poor sales, but she had the receipts – co-litigated with EEOC (first trans case litigated by EEOC) *Jamal v. Saks*, No. 4:14-cv-02782, U.S.D.C., S.D. Tex. – transgender employee terminated after harassment complaints ignored, amicably resolved

Lane v. Amazon, No. 2:17-cv-00134, U.S.D.C., N.D. Ky. – transgender employee and her husband harassed and complaints ignored, constructive termination - win at EEOC level, amicably resolved

Monegain v. Va. Dept. Motor Vehicles, No. 3:19-cv-721, U.S.D.C., E.D. Va. - DMV employee forced retirement after gender transition, amicably resolved after court decision denying dismissal of First Amendment claim, 491 F.Supp.3d 117 (E.D.Va. 2020)

Milo v. Cybercore, et al., NSA contractor terminated after gender transition, amicably resolved after court decision denying dismissal of wrongful termination claims, 2020 WL 134537 (D.Md. 2020)
